User guide

DESCRIPTION:

Chloro-active alkaline whitening solution.

FIELDS OF APPLICATION:

For cleaning and removing mold from walls and surfaces in stone, cotto, plaster, cement coatings, shower cubicles.

CHARACTERISTICS:

PULI MUFFE is a whitening cleaner for cleaning surfaces.

PULI MUFFE:

- sanitizes surfaces and helps remove blackening and mold from materials;
- is ideal for periodic cleaning of bathrooms, shower cubicles, ceramic tiles;
- can also be applied on plaster and raw wood.

INSTRUCTIONS FOR USE:

- Product ready to use;
- Spray PULI MUFFE directly on the surface to be cleaned;
- Leave for a few minutes and brush the surface with a kitchen sponge, or a white buffer or microfiber cloth;
- In the case of large and thick mold deposits let the product act for 30-60 minutes and if necessary use a nylon brush, so as to remove the organic scale in depth;
- Finally, rinse with clean water.

On colored paints or plasters, before using PULI MUFFE, test a small area to exclude any color changes. The product can opacify the methacrylate: pay attention near the bathtubs made with this material.

PRECAUTIONS:

- do not use on wood (especially if not painted), on wax treated absorbent materials (e.g. terracotta), glossy marble;
- protect metal and fabric surfaces from contact with PULI MUFFE;
- the product can opacify the methacrylate: pay attention near the bathtubs made of this material;
- on paints or coloured plasters, before using PULI MUFFE carry out a test on a small area to exclude any color changes.

TECHNICAL DATA:

- Physical state: straw-yellow liquid

STORAGE:

Keep the product tightly closed at temperatures between 0 °C and +30 °C and not exposed to sunlight for a long time. The stored product has a useful life of 2 years.
