



# SHOWER BRILL

ANTI-SCALE PROTECTIVE DETERGENT FOR BATHROOMS AND TOILETS



## User guide

### DESCRIPTION:

Detergent/protective solution based on surfactants and sequestrant agents.

### FIELDS OF APPLICATION:

For the ordinary cleaning and protection of surfaces in bathrooms and kitchens frequently wet by water (wall coatings and glass in shower cabins, sanitary ware, taps, bathtubs, washbasins, mirrors, etc.) in ceramic, metal (stainless and chromed steel), glass, plastic laminate.

### CHARACTERISTICS:

**SHOWER BRILL** is a detergent for the ordinary cleaning of ceramic, stainless and chromed steel, glass, plastic laminate frequently wet by water.

#### SHOWER BRILL:

- attacks the limestone left by the water, creating an invisible protective film on the material, which prevents the deposit of limestone and soap residues;
- with its use allows to obtain surfaces clean, protected and longer shiny;
- simplifies daily cleaning and avoids frequent intensive descaling.

SHOWER BRILL is not a descaling agent, therefore, in the case of surfaces with strong pre-existing limestone incrustations, proceed to their removal with SANI-KAL FORTE or SANI-KAL BIO before using SHOWER BRILL.

### INSTRUCTIONS FOR USE:

In the first application or on encrusted surfaces:

- We recommend before applying the product SHOWER BRILL to make an extraordinary descaling cleaning with SANI-KAL FORTE combined with the WHITE BUFFER MARBEC;
- Apply on clean, descaled and dry surfaces;
- Spray SHOWER BRILL on the clean surface, leave for a few minutes and rinse with water.

In the ordinary use of surface maintenance:

- Spray SHOWER BRILL directly on the surface still wet by the water (e.g. after showering), leave for a few minutes and then rinse with water.

### PRECAUTIONS:

- do not mix with bleach;
- do not use on polished limestone (e.g. marble and travertine), grits and black slate.

### NOTES:

#### YIELD:

- Depending on the concentration of use.

#### TECHNICAL DATA:

- Physical state: colourless liquid
- Specific gravity (g/cm<sup>3</sup>): 1,03
- pH (20°C) of the pure product: 3
- Flame point (ASTM): non-flammable
- Solubility in water: miscible in water

#### STORAGE:
